



NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Utility Board of Azusa Light & Water and City Council of the City of Azusa will hold a **JOINT PUBLIC HEARING** on Monday, March 7, 2022, at **7:30 P.M.**, or as soon thereafter as the matter may be heard, at the **Azusa Auditorium, 213 E. Foothill Boulevard, Azusa CA 91702**, to review the following agenda items:

RESOLUTION AMENDING THE FISCAL YEAR 2021/22 ELECTRIC FUND REVENUE AND EXPENDITURE BUDGETS BY \$2,005,430 AND \$2,759,201 RESPECTIVELY AND THE FISCAL YEAR 2021/22 WATER FUND EXPENDITURE BUDGET BY \$2,400,000: A public hearing to consider the adoption of a resolution to increase the FY 2021/22 Electric Revenues by \$2,005,430 due to higher commodity sales price sold to the wholesale market and increase Expenditure Budgets by \$2,759,201 due to higher commodity prices paid for purchases made from the wholesale market. Also increase the FY2021/22 Water Expenditure Budget by \$2,400,000 due to the need to purchase water from the Upper San Gabriel Valley Municipal Water District as a result of the drought. The **Proposed Budget Amendments** will be reviewed by **the Utility Board of Azusa Light & Water to amend the budget that is allowable by municipal code section 2.450.**

RESOLUTION AMENDING THE FISCAL YEAR 2021/22 GENERAL FUND SALES TAX AND TRANSACTION USE TAX REVENUE BUDGETS BY \$1,000,000 AND \$1,100,000 RESPECTIVELY: A public hearing to consider the adoption of a resolution to increase the FY 2021/22 GENERAL FUND SALE TAX Budget by \$1,000,000 and TRANSACTION USE TAX by \$1,100,000 as a result of an improving economy. The City Council will also review other City-Wide Budget Amendments that are below the \$1,000,000 threshold outlined under Municipal Code Section 2.450. The **Proposed Budget Amendments** will be reviewed by **the City Council of the City of Azusa to amend the budget that is allowable by municipal code section 2.450.**

All interested persons are notified to attend and express their opinions on these topics.

Any person wishing to testify may file a written statement prior to that time, and/or may appear and be heard.

If you challenge the proposed actions in Court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City Clerk or City Council at, or prior to, the public hearing.
